Equality Policy

Equality Policy

This policy is fully supported by the Club officers who are responsible for the implementation of this policy.

Preston North End Women's (Juniors) Football Club, in all its activities will not discriminate, or in any way treat anyone less favourably, on grounds of gender, sexual orientation, marital status, race, nationality, ethnic origin, colour, religion or belief, ability or disability. It means that Preston North End Women's (Juniors)

Football Club will ensure that it treats people fairly and with respect and that it will provide access and opportunities for all members of the community to take part in, and enjoy, its activities.

Preston North End Women's (Juniors) Football Club will not tolerate harassment, bullying, abuse or victimisation of an individual, which for the purposes of this policy and the actions and sanctions applicable is regarded as discrimination, this includes sexual or racially based harassment or other discriminatory behaviour, whether physical or verbal.

Preston North End Women's (Juniors) Football Club will work to ensure that such

behaviour is met with appropriate action in whatever context it occurs.

Preston North End Women's (Juniors) Football Club is committed to taking positive action where inequalities exist, and to the development of a programme of ongoing training and awareness, raising events and activities in order to promote the eradication of discrimination and promote equality in football.

Preston North End Women's (Juniors) Football Club is committed to a policy of equal treatment of all members and requires all members to abide and adhere to these policies and the requirements of the relevant equalities legislation - Race Relations Act 1976, Sex Discrimination Act 1975 and Disability Discrimination Act 1995 as well as any amendments to these acts and any new legislation.

Preston North End Women's (Juniors) Football Club commits itself to the immediate investigation of any claims, when it is brought to its attention, of discrimination on the above grounds and where such is found to be the case, a requirement that the practice stops and sanctions are imposed as appropriate.
